#### CHAPTER 14

### An Act to repeal the **Ontario Education Capital Aid Corporation Act and** the Ontario Universities Capital Aid Corporation Act

Assented to December 20th, 1985

HER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Ontario, enacts as follows:

- 1. In this Act, "Treasurer of Ontario" means the Trea- Definition surer of Ontario and Minister of Economics
- 2. The Ontario Education Capital Aid Corporation, con-Corporations tinued under the Ontario Education Capital Aid Corporation Act, being chapter 330 of the Revised Statutes of Ontario, 1980 and The Ontario Universities Capital Aid Corporation, continued under the Ontario Universities Capital Aid Corporation Act, being chapter 360 of the Revised Statutes of Ontario, 1980, are dissolved.

3. The assets and liabilities of The Ontario Education Transfer of Capital Aid Corporation and The Ontario Universities Capital liabilities to Aid Corporation are vested in the Treasurer of Ontario.

4. The Treasurer of Ontario may delete from the accounts Deletion of the Province of Ontario the advances made to The Ontario Education Capital Aid Corporation and The Ontario Universities Capital Aid Corporation.

5. The Treasurer of Ontario may, by written instrument Release of directed to the issuer of a debenture or bond vested in the and bonds Treasurer of Ontario by this Act, release in whole or in part the issuer of any such debenture or bond from its obligation to pay principal or interest or both on the debenture or bond.

6. The Ontario Education Capital Aid Corporation Act, Repeals being chapter 330 of the Revised Statutes of Ontario, 1980, and the Ontario Universities Capital Aid Corporation Act, being chapter 360 of the Revised Statutes of Ontario, 1980, are repealed.

Commencement 7. This Act comes into force on the day it receives Royal Assent.

Short title

8. The short title of this Act is the Capital Aid Corporations Repeal Act, 1985.
