CHAPTER 288

Ministry of the Solicitor General Act

- 1. In this Act, "Ministry" means the Ministry of the Interpre-Solicitor General. 1972, c. 2, s. 1.
- 2.—(1) The ministry of the public service known as the Minis-Ministry try of the Solicitor General is continued.
- (2) The Solicitor General shall preside over and have charge Solicitor General to of the Ministry. 1972, c. 2, s. 2.
- 3.—(1) The Lieutenant Governor in Council may appoint Solicitor a Deputy Solicitor General who shall be the deputy head General of the Ministry.
- (2) Such officers, clerks and servants may be appointed Staff under the *Public Service Act* as are required from time to R.S.O. 1980, time for the proper conduct of the business of the Ministry. ^{c. 418} 1972, c. 2, s. 3.
- 4. The moneys required for the purposes of the Ministry Moneys shall be paid out of the moneys appropriated therefor by Ministry the Legislature. 1972, c. 2, s. 4.
- 5. The Solicitor General is responsible for the administration Dutles of Solicitor of this Act, any Acts that are assigned to him by the General Legislature or by the Lieutenant Governor in Council and the following Acts:
