## CHAPTER 102

## An Act respecting Tordom Corporation

Assented to December 3rd, 1981

WHEREAS Tordom Corporation hereby represents that it is Preamble a loan corporation subject to the Loan and Trust Corpora- R.S.O. 1980, tions Act and is wholly owned by The Toronto Dominion Bank, 1980-81, a bank to which the Bank Act (Canada), applies; that as a result c. 40 (Can.); of the enactment of the Banks and Banking Law Revision Act, c. 40 (Can.); 1980 (Canada), it is in the best interest of Tordom Corporation R.S.C. 1970, c. L-12 that it be continued as a loan company under the Loan Companies Act (Canada); and whereas the applicant hereby applies for special legislation for such purpose; and whereas it is expedient to grant the application;

Therefore, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Ontario, enacts as follows: Application

1. Tordom Corporation may, provided it is authorized to do continuing so by the Loan Companies Act (Canada), apply for letters patent under continuing it as if it had been incorporated under that Act.

2. From the date on which Tordom Corporation is continued When under the Loan Companies Act (Canada), Tordom Corporation ceases to be ceases to be governed by the Loan and Trust Corporations Act governed by R.S.C. 1970, and must file with the Minister of Consumer and Commercial c. L-12; Relations a certified copy of the letters patent or other document  $\frac{R.S.O.}{c.}$  1980, certifying that is has been so continued.

3. This Act comes into force on the day it receives Royal Commence-Assent.

4. The short title of this Act is the Tordom Corporation Con-Short title tinuation Authorization Act, 1981.
