(Chapter 101)

An Act to revive Stacey's Custom Upholstery Limited

WHEREAS Stanley Stacey, Audrey Stacey and Marguerite Geddes hereby represent that Stacey's Custom Upholstery Limited, herein called the Corporation, was incorporated by letters patent dated the 23rd day of May, 1962; that the Provincial Secretary, by an order dated the 12th day of October, 1967, and made under the authority of subsection 2 of section 326 of *The Corporations Act*, being chapter 71 of the Revised Statutes of Ontario, 1960, cancelled the letters patent of the Corporation for default in filing annual returns and declared it to be dissolved on the 16th day of November, 1967; that the applicants were all the directors of the Corporation at the time of dissolution; that default in filing the annual returns occurred by reason of inadvertence; that the Corporation at the time of its dissolution was actively carrying on the business authorized by its letters patent and since that time active business has continued to be carried on in the name of the Corporation and in the name of Stacey's Custom Upholstery; and whereas the applicants hereby apply for special legislation reviving the Corporation; and whereas it is expedient to grant the application; Preamble

Therefore, Her Majesty, by and with the advice and consent of the Legislative Assembly of the Province of Ontario, enacts as follows:

1. Stacey's Custom Upholstery Limited is hereby revived and is, subject to any rights acquired by any person after its dissolution, hereby restored to its legal position as a company incorporated by letters patent, including all its property, rights, privileges and franchises and subject to all its liabilities and debts as at the date of its dissolution in the same manner and to the same extent as if it had not been dissolved.
