APPENDIX A

Certain Imperial Acts and Parts of Acts relating to Property and Civil Rights that were Consolidated in The Revised Statutes of Ontario, 1897, Volume III, pursuant to Chapter 13 of the Statutes of Ontario, 1902, that are not repealed by the Revised Statutes of Ontario, 1970 and are in force in Ontario subject thereto.

R.S.O. 1897, CHAPTER 322

An Act respecting Certain Rights and Liberties of the People

IS MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Ontario, enacts as follows:-

2. No man shall be taken or imprisoned nor prejudged of life or Imprisonlimb, nor be disseized or put out of his freehold, franchises, or ment, etc., contrary liberties, or free customs, nor be outlawed, or exiled, or any to law. otherwise destroyed, unless he be brought in to answer and Administraprejudged of the same by due course of law; nor shall the King justice. pass upon him, nor condemn him, but by lawful judgment of his peers, or by the law of the land; and the King shall sell to no man. nor deny or defer to any man, either justice or right. 25 Edw. 3. It is provided, agreed, and granted, that all persons, as well of wrongful of high as of low estate, shall receive justice in the King's court; or defiances and none from henceforth shall take any revenge or distress of his of the King's own authority, without award of the King's court, though he have courts. damage or injury, whereby he would have amends of his neighbour, either higher or lower. 52 Hen.
