IMPERIAL, 49-50 VICTORIA, CHAPTER 35

An Act respecting the Representation in the Parliament of Canada of Territories which for the time being form part of the Dominion of Canada, but are not included in any Province

[25th June, 1886]

[] HEREAS it is expedient to empower the Parliament of Repealed by Canada to provide for the representation in the Senate and the Statute Law Revision House of Commons of Canada, or either of them, of any territory Act, 1898, 61-62 V which for the time being forms part of the Dominion of Canada, but is c. 22 (Imp.). not included in any province:

Be it therefore enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:

1. The Parliament of Canada may from time to time make Provision provision for the representation in the Senate and House of by Parli Commons of Canada, or in either of them, of any territories which Canada for representafor the time being form part of the Dominion of Canada, but are tion of not included in any province thereof.

2. Any Act passed by the Parliament of Canada before the Effect of Acts passing of this Act for the purpose mentioned in this Act shall, if of Canada. not disallowed by the Queen, be, and shall be deemed to have been, valid and effectual from the date at which it received the assent, in Her Majesty's name, of the Governor-General of Canada.

It is hereby declared that any Act passed by the Parliament of 34 and 35 Canada, whether before or after the passing of this Act, for the purpose mentioned in this Act or in the British North America Act. 1871, has effect, notwithstanding anything in the British North America Act, 1867, and the number of Senators or the number of Vict., c. 3. Members of the House of Commons specified in the last-mentioned Act is increased by the number of Senators or of Members. as the case may be, provided by any such Act of the Parliament of Canada for the representation of any provinces or territories of Canada.

Short title and construction. 30 and 31 Vict., c. 3. 30 and 31 Vict., c. 3. 34 and 35 Vict., c. 28.

3. This Act may be cited as the British North America Act, 1886.

This Act and the *British North America Act*, 1867, and the *British North America Act*, 1871, shall be construed together, and may be cited together as the *British North America Acts*, 1867 to 1886.
