## CHAPTER 110

**An Act to amend  
The Ontario Municipal Board Act**

*Assented to June 30th, 1972  
Session Prorogued December 15th, 1972*

**H**ER MAJESTY, by and with the advice and consent of the Legislative Assembly of the Province of Ontario, enacts as follows:

**1.** Section 15 of *The Ontario Municipal Board Act*, being <sup>s. 15,</sup> chapter 323 of the Revised Statutes of Ontario, 1970, is <sup>re-enacted</sup> repealed and the following substituted therefor:

**15.** The chairman may in writing authorize one member of the Board to hear and determine any application to the Board and for such purpose such member may exercise all the jurisdiction and powers of the Board and his decision on the application shall be a decision of the Board. <sup>One member may hear and determine application</sup>

**2.** Section 99 of the said Act is repealed and the following <sup>s. 99,</sup> substituted therefor: <sup>re-enacted</sup>

**99.—(1)** The Board may, with the approval of the Lieutenant Governor in Council, make regulations requiring fees to be paid to the Board in connection with its proceedings and prescribing the amounts thereof. <sup>Fees</sup>

**(2)** The Board may from time to time waive or remit in appropriate circumstances all or any portion of such fees. <sup>Where fees may be waived or remitted</sup>

**3.** This Act comes into force on the day it receives <sup>Commence-</sup> Royal Assent. <sup>ment</sup>

**4.** This Act may be cited as *The Ontario Municipal Board* <sup>Short title</sup> *Amendment Act, 1972.*
